

# BOARD OF REGISTERED NURSING

## PROPOSED LANGUAGE

The Board of Registered Nursing hereby amends the following regulation in Division 14 of Title 16 of the California Code of Regulations.

**(1) Amend Section 1417 of Division 14 of Title 16 of the California Code of Regulations to read as follows:**

**1417. Fees.**
