<b>SUBJECT</b>	<b>Status of the Office of Professional Examination Services AB 890 Nurse Practitioners Project</b>

The purpose of this memo is to provide an update of the Office of Professional Examination Services (OPES) AB 890 Nurse Practitioners Project.

As mandated by AB 890 (Wood, Chapter 265, Statutes of 2020), the California Board of Registered Nursing (Board) has contracted with OPES to conduct an occupational analysis of the Nurse Practitioner profession in California. In addition, the Board has contracted with OPES to perform a psychometric review of the following nurse practitioner certification examinations:

  - Family Nurse Practitioner (FNP)
  - Adult Gerontology Primary Care Nurse Practitioner (A-GNP)
- American Association of Critical-Care Nurses (AACN)
  - Acute Care Nurse Practitioner - Adult Gerontology (ACNPC-AG®)
- American Nurses Credentialing Center (ACNP)
  - Family Nurse Practitioner (FNP-BC™)
  - Adult-Gerontology Primary Care Nurse Practitioner (AGPCNP-BC®)
  - Adult-Gerontology Acute Care Nurse Practitioner (AGACNP-BC®)
  - Psychiatric-Mental Health Nurse Practitioner (Across the Lifespan) (PMHNP-BC™)
- National Certification Corporation (NCC)
  - Women's Health Care Nurse Practitioner (WHNP-BC®)
  - Neonatal Nurse Practitioner (NNP-BC®)
- Pediatric Nursing Certification Board (PNCB)
  - Certified Pediatric Nurse Practitioner - Acute Care (CPNP-AC)
  - Certified Pediatric Nurse Practitioner - Primary Care (CPNP-PC)
