#### **ROLE OF AN EXPERT PRACTICE** CONSULTANT

- Reviews investigative case materials and prepares written opinions.
- Reviews facts independently and impartially.
- Establishes whether or not a departure from the standard of nursing practice occurred.
- Complies with Board requirements when performing reviews or evaluations.
- Able to complete and submit a written opinion within 21 calendar days of receipt of case materials.

 Willing and available to testify at administrative hearings before an administrative law judge.

#### **QUALITIES OF A SUCCESSFUL EXPERT PRACTICE CONSULTANT**

- Objective, fair, and unbiased.
- Understands the standard of care.
- Effective communicator, both when testifying and in writing reports.
- Able to maintain confidentiality.
- Capable of reaching a final conclusion and remaining steadfast.

#### **MINIMUM REQUIREMENTS TO QUALIFY**

- Must be a California resident with an active California RN license.
- Ten or more years of experience as an RN.
- Minimum of five years of clinical practice experience in the area of expertise and current employment in that setting.
- No prior or current discipline against any health care-related license or certification.

- Have at least three years experience in evaluating mental health and/or substance use disorders.

Psychologists are compensated at a rate of \$150 an hour. Psychiatrists and physicians are compensated at a rate of \$175 an hour.
