#### Introduction

It has been one year since the California Board of Registered Nursing's (Board or BRN) previous sunset review in 2021. The BRN continues its commitment of public protection through its six main program areas: Consumer Services and Board Operations; Office of Legislative Affairs; Licensing; Nursing Education; Continuing Education and Research; and Enforcement.

The Board strives to have high-quality customer service standards. Despite some delays the Board has experienced in processes and challenges with customer service, the Board has taken many steps to improve, and will continue to evaluate means to enhance customer service and shorten processing timeframes. Additionally, the Board launched efforts to identify process improvements and implement strategies to achieve enhanced efficiencies.

This report demonstrates the outstanding work performed by the Board and Board staff. The Board respectfully awaits a determination regarding our new sunset review period from the Governor's Office, Senate Business, Professions and Economic Development Committee, and Assembly Business and Professions Committee.

### **Board Committees**

Pursuant to Business and Professions Code (BPC) section 2701, the Board is composed of nine members, although at this time only six positions are filled. When all positions are filled, the Board composition includes four public members, two Registered Nurses (RN) in direct patient care practice, an Advanced Practice Registered Nurse (APRN), a RN educator, and a RN administrator. Seven of the members are appointed by the Governor, one by the Senate Rules Committee, and one by the Speaker of the Assembly. The Board meets at a minimum four times throughout the year to transact the business of the Board.

The Board members work effectively through a structure of five standing Board committees.

#### Administrative Committee (non-statutory)

Considers and advises the Board on matters related to Board organization and administration. The committee is comprised of the Board President and Vice President.

## **Other Committees**

The Nurse Practice Act authorizes the appointment of specific committees: The Nurse-Midwifery Advisory Committee (NMAC), the Nurse Practitioner Advisory Committee (NPAC), and the Intervention Evaluation Committees (IECs). The Board is also authorized under BPC section 2710.5 to appoint other advisory committees, with permission of the Director of DCA, as needed to advise the Board on nursing matters. Membership on these committees includes a variety of experts and stakeholders but are not Board Members. The advisory committees are convened on an as-needed basis.

- Nurse Practitioner Advisory Committee (BPC section 2837.102)
- Nursing Education and Workforce Advisory Committee (NEWAC) (non-statutory)
- Advanced Practice Registered Nursing (APRN) Advisory Committee (non-statutory)

At the August 2021 Board meeting, the Board voted to maintain the APRN Advisory Committee with a focus on CRNAs, CNSs, and issues that affect all APRN groups, excluding issues solely affecting NPs and CNMs. Maintaining the APRN Advisory Committee with this specific focus prevents two committees with overlapping authority which could create confusion, conflicting recommendations, and may affect the timeliness of information presented to the Board after being heard by multiple advisory committees.

At the November 2021 Board meeting, the Board voted to continue the NEWAC with a reduction in its membership from its current roster of 27-29 advisory committee members to 16 members. This membership reduction will reduce challenges associated to establishing quorums and allow for a balanced representation. The new membership will have three (3) education/academic representatives, three (3) employer representatives, three (3) currently practicing RN and APRNs to represent workforce, three (3) people dedicated to research, three (3) union representatives and one (1) public member. Next year's focus will be to provide guidance to the Board on California Code of Regulations (CCR) section 1426 to identify efficiencies for RN education related to licensure through endorsement and establish a requirement for minimum direct patient care hours thus removing a cap on simulation percentages which allows for nursing program directors to determine the amount of simulation best suited for their program and students.

## Change in Leadership

#### **Chief of Legislation**

In March 2021, Thelma Harris, the Board's Chief of the Office of Legislative Affairs resigned from this position. This position is currently in the recruitment phase.

#### **Chief of Enforcement**

The Board welcomed Shannon Johnson in her new role as the Chief of Enforcement in October 2021. Ms. Johnson has been with the Board for more than 14 years. She has served in various positions including Discipline Manager, Deputy Chief of Intervention and Investigation and the last four years as the Deputy Chief of Discipline, Probation, and Intervention in the Enforcement Division. She holds a bachelor's degree in Business with a focus on Management. Ms. Johnson's experience and knowledge will continue to be an asset to the Board.

#### **Deputy Chiefs of Enforcement**

Applications received for this vacancy in March 2021 resulted in first and second round interviews being conducted; however, a new recruitment will be released with the recruitment to backfill Ms. Johnson's former Deputy Chief position.

### Major Studies and Publications

#### Annual Survey of RN Educational Programs

The 2020-2021 Annual School Survey was released to the California approved nursing programs in October 2021 with an anticipated publication date in 2022.

#### **BRN Reports**

The BRN published the Fall 2021 edition of the "BRN Report" online newsletter.

#### **Strategic Plan**

In November 2021, the Board formally adopted its 2022-2025 Strategic Plan. During the development of this Strategic Plan, the Board made changes to its mission, vision, and values to align its efforts to create a sustainable foundation to serve in the future.

#### **Annual Reports**

Every year the BRN provides statistical information to DCA for inclusion in its annual report.

#### Updates Since Last Sunset Review

#### 2018-2021 Strategic Plan

Overall, the Board met its goals and objectives of its 2018-2021 Strategic Plan. As part of the winddown efforts, the Board conducted an analysis of its strengths, and areas of opportunity for improvement, and applied these lessons learned to its 2022–2025 Strategic Plan.

#### California State Auditor (CSA) Investigative Report I2020-0027

All three recommendations of the CSA Investigative Report I2020-0027 are fully implemented.

#### CSA Audit 2016-046

The BRN established and implemented a plan to eliminate the backlog of complaints awaiting assignment to an investigator and continues to be available to the CSA Audit Team to demonstrate full implementation of Audit 2016-046 Recommendation 7, which states: "To ensure that BRN resolves complaints regarding nurses in a timely manner, by March 1, 2017, it should establish a plan to eliminate its backlog of complaints awaiting assignment to an investigator."

#### CSA Audit 2019-120

In the CSA Audit 2019-120, there were nine recommendations made to the BRN. The BRN has fully implemented five recommendations and continues to progress towards full implementation of the remaining four recommendations. These four recommendations are interrelated and are anticipated to be fully implemented upon collection, analysis, validation, and generation of a report to be published to the BRN's website concerning clinical facility data.

#### **Public Counter**

Effective January 1, 2022, the BRN's Public Counter will align itself to the practices of other boards and bureaus under DCA and will no longer review applications, review documentation submitted, or approve applications for licensure or exam. The BRN Public Counter will accept and date stamp documents, accept payments via check, money order, or cash, and provide forms and/or paper applications.

#### COVID-19

On January 25, 2021, the Director of DCA issued waiver DCA-21-105 regarding RN temporary licenses. The waiver was effective immediately and allowed BRN to issue a temporary license to RN applicants that apply for licensure pursuant to BPC section 2732.1(b), between July 1, 2020, and June 30, 2021 without submitting an application and fee for a temporary license if certain conditions were met. The waiver was extended twice through October 31, 2021. This allowed the BRN to quickly issue temporary licenses to qualified nurses from out of state to begin practicing and providing relief in California immediately.

All DCA waivers impacting the field of nursing can be found on the DCA website.

#### Amazon Web Services (AWS)

The new AWS phone system (Amazon Connect) went live on March 16, 2021. This new system allows for callers to enter their phone number and receive a call back without losing their place in the queue, thereby eliminating the need to wait on hold. The BRN continually monitors the statistics from this system to guide future streamlining efforts, find ways to better assist callers, and identify training opportunities for Public Information Unit (PIU) staff.

#### Advanced Practice Registered Nursing Performance Targets

As reported in the 2020 Sunset Report, the BRN was not meeting its target or statutory timeframes for processing both NP and Public Health Nurse (PHN) applications. In response, the BRN implemented steps to reevaluate its business processes to improve its processing times for NP and PHN applications, utilizing more paperless options and implementing IT enhancements including BreEZe revisions. In addition, BRN redirected and trained additional staff and authorized overtime, as appropriate. With these process improvements, the BRN is now meeting its statutory timeframe for conducting an initial review and providing written notification to the applicant within 30 calendar days of receipt of an application. The BRN anticipates automating the PHN process in the first quarter of 2022.

#### Implementation of AB 890 (BPC section 2837)

The BRN established NPAC to advise and give recommendations to the Board on matters related to NPs. This committee presented proposed regulatory language to the Board to address the implementation of BPC 2837.101, 2837.103 and 2837.104 which the Board approved with revisions. Additionally, the DCA's Office of Professional Examination Services (OPES) is performing the occupational analysis, included but not limited to, conducting workshops with subject matter experts.

#### Implementation SB 1237 (BPC section 2746)

The BRN established NMAC to advise and give recommendations to the Board on matters related to CNMs. NMAC voted to formulate a frequently asked questions (FAQ) document to present to the BRN for publishing to the website. This document is intended to provide clarification and be a resource for consumers.

#### **Online Application Efforts**

To improve the processing times of applications and increase efficiencies of resources, the BRN, after ensuring all applications are available through BreEZe, removed the paper applications from the BRN website. The applicants/licensees are encouraged to submit applications electronically via BreEZe and monitor their application progress through the new Application and Details Status Page (see below in 'Efficiencies Since Last Sunset'). Paper copies are available upon request.

#### Expedited Licensure Process for Refugees, Asylees, and Holders of Special Immigrant Visas

Assembly Bill (AB) 2113 (Low, Chapter 186) was implemented on January 1, 2021. This bill added BPC section 135.4, which provides an expedited licensure process for individuals in the following categories:

1. Refugees pursuant to section 1157 of title 8 of the United States Code;

- 2. Those granted asylum by the Secretary of Homeland Security or the Attorney General of the United States pursuant to section 1158 of title 8 of the United States Code; or,
- 3. Individuals with a special immigrant visa that have been granted a status pursuant to section 1244 of Public Law 110-181, Public Law 109-163, or section 602(b) of title VI of division F of Public Law 111-8.

The BRN updated the RN applications to add a new question and instructions to address requests for the expedited licensure process. Additionally, updates were made to the BRN website with links to the updated applications and DCA's webpage.

## **Efficiencies Achieved Since Last Sunset**

#### **Dedicated IT Contractor**

To improve processing timelines and reduce errors, the BRN, in collaboration with DCA, contracted with a consultant for specific IT and BreEZe system enhancements.

#### Enlighten Licensing Project

The BRN volunteered to be the first board within DCA to participate in the DCA Enlighten Licensing Project. This project brings together licensing and IT subject matter experts from DCA boards and bureaus to identify ways to streamline licensing processes, both internally and externally, for greater efficiencies. Presentations have been given to DCA staff, board executive officers, and bureau chiefs on the following processes: RN examination and endorsement applications, out of state verifications, and initial NP certification. The BRN looks forward to the project's final recommendation report that DCA will provide, which will help streamline business processes and reduce processing timeframes.

#### Application and Details Status Webpage

On June 7, 2021, through collaboration with DCA, the BRN launched the Application Status and Details webpage on the BRN's website. This new webpage provides applicants and licensees with detailed information and the progression of their initial and renewal applications, including any items that are deficient. The first phase included RN and APRN initial and renewal applications with additional applications to be subsequently added.

#### Out of State Nurse Practitioner Programs

The BRN updated its website to provide the forms and instructions on how out of state NP program may request verification of the program's compliance with CCR section 1486 to obtain Board approval. The BRN partnered with DCA's Organizational Improvement Office to document process flowcharts and outline process improvements. This effort yielded a streamlined process for both the applicant and the Board to conduct its review.

#### **Temporary License Info Button**

On May 18, 2021, the BRN added a Temporary License Information button to the BRN website. The button takes potential applicants to the Temporary License page that provides information on how to apply for a Temporary License and other pertinent information.

#### California Nursing Program Portal

The BRN, in collaboration with DCA and the contracted IT vendor, developed a new secure education history portal available to the California Board-approved prelicensure nursing programs. The new portal will be used by the Board-approved Director of Nursing (DON) to query a report of all applicants for initial licensure by examination located in BreEZe based on their assigned school code.

Once the DON verifies that the applicant completed the licensing education requirements through that approved program, the DON will enter the student's completion and/or graduation information and will electronically submit that information to the BRN. Upon submission, the verified data will be uploaded into BreEZe and will issue exam eligibility to the applicants and transmit that to Pearson Vue, the exam vendor who will issue the Authorization to Test (ATT). This process eliminates the need for submission of individual school transcripts and expedites this process. This allows students to schedule their NCLEX date sooner than in the past. In general, the earlier a graduate takes the NCLEX after completing a nursing program, the higher the likelihood of successfully passing the exam.

On October 19, 2021, the first California-approved nursing program successfully utilized the new portal and the DON expressed how easy it was to verify, validate, and upload the student's information. Licensing Program staff and Nursing Education Consultants (NECs) continue to monitor and assist the DON through the process.

#### **Out of State License Verifications**

In April 2021, BreEZe was updated to add the ability to request verification of a license and payment of the verification fee online. This capability is available to all licensees and is available via their BreEZe accounts. Additionally, all microfilm records were converted to digital records and are now housed in an electronic file management system, which allows the BRN to access those records on demand.

To further improve the process for California licensed RNs to request and provide license verification, during the November 2021 Board meeting, the Board voted to utilize NURSYS®, an online verification system provided through the National Council of State Boards of Nursing (NCSBN) to provide the license verification service for RNs licensed in California. This aligns the BRN with other states and territories using NURSYS® for their license verification.

In collaboration with NCSBN, the BRN is targeting a go-live date of January 10, 2022 for NURSYS® to assume California license verification. It is anticipated in December 2021, the BRN will launch a campaign on all communication platforms, including but not limited to, Facebook, Twitter, BRN website, and BRN ListServ to direct RNs to Nursys.com rather than the BreEZe system.

#### Photo Requirement for Applications

In July 2021, the BRN removed the requirement for the submission of a passport-like photo from the applicant as a means of establishing identity. The requirement previously resulted in a high number of deficiencies and inquiries to the BRN. A photo is included with the NCLEX results received by the Board and maintained in the applicant's licensure record as a means of establishing identity.

#### **Document Requirements for Reapply/Repeat Examination Applications**

In July 2021, the BRN removed the requirement for the submission of duplicate transcripts and other documentation for reapply/repeat examination applications, which is expected to allow for reduced processing timeframes.

#### Cross-Training of Public Information Unit Staff on Licensing Application Processing

On October 14, 2021, training was conducted for PIU staff on initial review of endorsement applications to assist with callers at the initial point of contact to minimize the need for subsequent calls to the BRN. Future training on additional licensing activities to improve customer service, reduce processing timeframes and increase efficiencies are in development and will be scheduled as appropriate.

#### Joint Continuing Approval Visit (CAV)

On September 28-29, 2021, in an effort to reduce duplication and restructure continuing approval processes for nursing programs, the BRN participated in its first joint CAV with the Accreditation Commission for Education in Nursing (ACEN). This joint effort identified similarities but confirmed the vast differences between an accreditor's process utilizing an evaluation approach and the role of a regulator who serves as a consultant. The BRN aligned future CAVs with accreditation visits and will leverage the accreditor's review to reduce duplication and increase efficiency where possible.

#### Legislation

The BRN has not sponsored any legislation since the last sunset report. The BRN's involvement in the legislative arena includes tracking bills and reporting through the Legislative Committee to the Board, testifying at legislative hearings, and implementing legislation that impacts the Board. The following is key legislation that was chaptered in 2021 and directly impacts the Board and/or the field of nursing:

• **AB 107** (Salas): Licensure: veterans and military spouses Along with other provisions, requires a DCA board to issue a temporary license within 30 days of receiving the required documentation if the results of a criminal background check do not show grounds for denial, and would require a board to request the Department of Justice to conduct the criminal background check and to furnish the criminal background information in accordance with specified requirements. This law, on and after July 1, 2023, would provide that temporary licenses are nonrenewable and shall expire 12 months after issuance.

Chaptered by Secretary of State – Chapter 693, Statutes of 2021

• **AB 361** (Rivas): Open meetings: state and local agencies: teleconferences Allows, until January 1, 2024, local agencies to use teleconferencing without complying with specified Ralph M. Brown Act restrictions in certain state emergencies, and provides similar authorizations, until January 31, 2022, for state agencies subject to the Bagley-Keene Open Meetings Act and legislative bodies subject to the Gloria Romero Open Meetings Act of 2000.

Chaptered by Secretary of State – Chapter 165, Statutes of 2021 and effective October 1, 2021, per Executive Order N-15-21

• **AB 468** (Friedman): Emotional support animals Prohibits a health care practitioner from providing documentation relating to an individual's need for an emotional support animal unless the health care practitioner complies with specified requirements, along with other provisions.

Chaptered by Secretary of State – Chapter 168, Statutes of 2021

• **AB 1015** (Rubio): Board of Registered Nursing: workforce planning: nursing programs: clinical placements

Requires the BRN to incorporate regional forecasts into its biennial analyses of the nursing workforce; develop a plan to address regional areas of shortage identified by its nursing workforce forecast, as specified; and annually collect, analyze, and report information related to the number of clinical placement slots that are available and the location of those clinical placement slots within the state.

Chaptered by Secretary of State - Chapter 591, Statutes of 2021

 AB 1273 (Rodriguez): Interagency Advisory Committee on Apprenticeship: the Director of Consumer Affairs and the State Public Health Officer Expands the use of the "earn and learn" training model by preventing DCA Boards from prohibiting its use for personnel training or accreditation of programs and requiring them to use licensing or certification standards that authorize it. Chaptered by Secretary of State - Chapter 477, Statutes of 2021

• **AB 1407** (Burke): Nurses: implicit bias courses

Requires a nursing program or school to include one hour of direct participation in implicit bias training; requires a RN to complete one hour of implicit bias continuing education within the first two years of licensure; and requires a hospital to implement an evidence-based implicit bias program as part of any new graduate training program that trains new RNs.

Chaptered by Secretary of State – Chapter 445, Statutes of 2021

 AB 1477 (Cervantes): Maternal mental health Requires a licensed health care practitioner who provides prenatal, postpartum or interpregnancy care, to ensure that the mother is offered screening or is appropriately

Chaptered by Secretary of State – Chapter 535, Statutes of 2021

• AB 1532 (Com. On Bus. & Prof.): Nursing

Extends the operations of the BRN, by one year; requires the BRN to post the availability of its temporary licenses on the front page of its website; and makes other technical and clarifying changes.

Chaptered by Secretary of State – Chapter 628, Statutes of 2021

• SB 306 (Pan): Sexually transmitted disease: testing

screened for maternal mental health conditions.

Permits pharmacists to dispense a drug, without the name of an individual for whom the drug is intended, when prescribed for the sexual partner of someone who has been diagnosed with a sexually transmitted disease (STD); prohibits health care providers who prescribe, dispense, or furnish such a drug from being subject to civil, criminal, or administrative penalties, as specified; requires a syphilis blood test during the third trimester of pregnancy and at delivery, as specified; requires public and commercial health coverage of home STD test kits; and adds rapid STD tests to existing law which permits HIV counselors to perform rapid HIV and hepatitis C tests.

Chaptered by Secretary of State - Chapter 486, Statutes of 2021

• SB 607 (Min): Professions and Vocations

Makes various changes to the operations of a number of DCA boards and bureaus. Requires, on and after July 1, 2022, a DCA board to waive the licensure application fee and the initial or original license fee for an applicant who meets expedited licensing requirements.

Chaptered by Secretary of State - Chapter 367, Statutes of 2021

## Regulations

The Board continues the process of promulgating regulations in several areas. Currently the Board has four regulations packages with the Office of Administrative Law (OAL), with other packages in various stages of the regulatory process. The four regulatory packages with OAL are:

- Amend CCR, Title16, Section 1427 (Clinical Facilities)
- Amend CCR, Title 16, Section 1484 (Nurse Practitioner Education)
- Amend CCR, Title 16, Sections 1450 and 1456 (Definitions and Continuing Education Courses)
- Amend CCR, Title 16, Sections 1423 and 1432 (Approved Program/Program Approval)

#### Section 5: Fiscal Updates

#### Anticipated Deficit, General Fund Loans, and Fee Changes

In Fiscal Year (FY) 2020/2021, the Department of Finance transferred \$30,000,000 from the BRN Fund to the General Fund to help aide with COVID-19 budget constraints on the General Fund. The BRN Fund is projected to decline to less than five months in reserve in FY 2021/2022 after the loan to the General Fund; however, the BRN funding reserve levels are projected to grow at a rate of approximately 0.4 months in reserve over the next two FYs. The loan is scheduled to be repaid back by FY 2024/2025.

## Budget Change Proposal (BCP)

For FY 2021/2022, with BCP 1111-010-BCP-2021-GB, the BRN requested \$2.1 million to the Board of Registered Nursing Fund, Professions and Vocations Fund in FY 2022/23 and ongoing to fund 22.0 positions to address deficiencies within the Licensing Division and the Board Operations and Consumer Services Division.

## Staffing Challenges, Recruitment/Retention, and Succession Planning

The BRN has NECs throughout the state of California in three different program areas (nursing education, enforcement, and CE). The table below shows the NEC vacancy rate for BRN assignment area as low as 46 percent and as high as 100 percent. These positions are difficult to recruit and retain. The BRN continues to have challenges in recruiting qualified NECs due to the salary inequity of these positions compared to equivalent jobs outside of state service for RNs. Additionally, there are other state agencies that have RN classifications whose salaries are higher than the NECs. The BRN has requested that the California Office of Human Resources (CalHR) address the pay inequity; however, to date, these requests have not been successful.

Recruitment/retention and succession planning includes, but is not limited to, staff development and training.
