Executive Officer report

5.1 Provided by Loretta Melby, Board of Registered Nursing Executive Officer.

Board Discussion: Patricia Wynne asked if the NEC salary is competitive.

Loretta Melby said it is not. She said it was addressed in the sunset report. She also brought this issue when she was a NEC prior to appointment as Executive Officer to the union. She said new grads hired by Sutter earn \$150,000 per year which is not close to what NECs earn. She said NECs rely on their partners for additional income or a pension to supplement income. She said she's worked with DCA's Office of Human Resources and the BRN's budget is supportive of the pay increase requests that have gone through. She does not believe 5% is a competitive rate.

Patricia Wynne said the board would like to know what they can do to help.

Loretta Melby discussed some of the bargaining issues being dealt with at CalHR and the Governor's office.

Alison Cormack is very interested in learning more about the Enforcement Enlightenment project as a new board member.

5.4 Information only: Presentation by the National Council of State Nursing Boards (NCSBN) on the new nursing shortage report

Board Discussion:

Patricia Wynne appreciates the nationwide context. She asked about the smart policy decisions could help stop the loss of nurses and what that means.

Brendan Martin. Director of Research at National Council of State Boards of Nursing, said there was a generational shift with the large group of nurses who left the profession, over 200,000 of the 330,000 nurses who left the workforce were nurses who opted to retire earlier than originally planned. There was a loss of institutional knowledge. Younger, less experienced nurses remained who had acute experiences with the Covid-19 pandemic, potentially leaving them feeling more burned out and stressed. In addition, there are new nurses who are less confident and prepared for the workforce. There should be an all solutions on the table type of approach to this including some form of virtual nursing as a way to recapture some of the lost institutional knowledge from nurses who have retired; mental health services with intentional policies to ensure the current workforce has what they need to stay on top of their license; fully funded and formal transition to practice internships and residencies for new nurses to perform to the top of their license; significant efforts to retain and attract new nurse faculty to expand the number of clinical placements what are the forms of remote learning and simulation that are most effective at the pre-licensure level.

Brendan's background is in research and to gather data to provide to the experts to have the conversation needed to make change to address the problems that exist.

Alison Cormack would like the link to the Journal of Nursing Regulation (70-page report). She asked what the direct mail response rate was. Brendan said there was about a 20% rate from the RNs, and an aggregate rate of 17%. He discussed surveys and the specialized

group of nurses involved in surveys. Alison Cormack asked how long the survey is.

Brendan said there are 39 items. He discussed the types of questions and response formats. It is two pages back and front. It takes about 10 minutes to complete.

Alison Cormack spoke about survey overwhelm. She asked about the 41,000 with the mean age of 36 leaving the profession and if it was the effect of being a parent of young children.

Brendan said there were opportunities for open ended responses from the nurses to help gather data. He said they were able to isolate this because of burnout. He discussed the potential of 800,000 nurses leaving in a five-year period.

Alison Cormack asked how nursing schools teach about the mental health challenges of the demanding job and what the requirements are.

Loretta Melby said the board sets curricular requirements but does not set them up for mental health. The board does not have this regulatory authority.

Alison Cormack asked if someone has that regulatory authority.

Loretta Melby said the schools have student services requirements that are not under BRN jurisdiction.

Alison Cormack asked about starting outreach in high school and looking at the life cycle of a nurse in a more holistic straightforward manner to make decisions at different points along the way.

Dolores Trujillo asked if the 800,000 number was looked at in the nation and stood out in any way.

Brendan said it is against their nature to dis-aggregate the data nationally. But they did look at this data in a sub-analysis as compared with other rigorously conducted studies. He said the results were incredibly durable and consistent. They did not see a pocket of data, but urban or metro locales had a bit more acute experience with the pandemic.

Girard Brogan, Director National Nurses United – Stated Nurses United had done several surveys with their members and COVID has

exacerbated the inherent stress in nursing. They see the main reasons for nurses leaving, are staffing, lack of support from administration, and workplace violence. They are working on legislation to resolve this.

Kathy Hughes, RN, SEIU Nurse Alliance – She said the pay issue is a huge thing for nurses who work for the state. She said the California Department of Public Health (CDPH) did not enforce nurse to patient ratios during the pandemic. She said administration did not support nurses during the pandemic. She said the Centers for Disease Control (CDC) is looking to reduce infectious control or infectious disease standards to 2007 levels. She spoke about the younger nurses seeking other careers due to the stress and conditions currently experienced.

Carmen Comsti, CNA, affiliate of Nurses United – The NCSBN survey solidifies the experiences their members have lived through the past three and a half years. Nurses experienced these issues prior to the pandemic but Covid exacerbated the crisis of unsafe staffing and unsafe working conditions driven by employer neglect of the healthcare workforce. She said 38.1% disagreed with organization really cares about my wellbeing, 41.9% disagreed with the statement my organization responds to my complaints. She appreciates the board's focus on this issue today.

She said if the patient does not show up then a new patient label is put on the hydration and administered to another patient, and this causes the safety issues.

She said a lot of times it isn't the nurse making the claims its the company they work for. Then it would be Federal Trade Commission looking at this.

Angie Camacho written comment – The CNO of Temecula Hospital thanks the board for their support as they partner with United Nursing by providing them clinical placement for their students.

Julia Robinson, Dean of United Nursing College – Said they would like to increase their enrollment to 120 because they have the clinical placements to support this. Loretta Melby said the original request to committee was 90 annually not 120. She asked if the assigned NEC has information to support this request. She explained it takes 6 months to get through the feasibility process. She suggested the board consider the request for 90 students while the increase is vetted by the assigned NEC and presented to the board at a future meeting. Dolores Trujillo said the materials support the 90 students but does not show the 120. Julia Robinson said they submitted the request for 120 and is unsure why the information did not make it into the board materials. Loretta Melby said this is not the final step in the approval process and the enrollment number could be changed going forward with the self-study. She said the program could be brought prior to the self-study to

include the enrollment change. Dolores Trujillo asked if the motion could stand. Loretta Melby said it could. If the board is interested in a new motion, then the current motion would have to fail. Dolores Trujillo asked what happens if it does not fail. Loretta Melby explained it would go forward as is.

Loretta Melby said materials may be submitted at the board meeting if they aren't included in the posted materials.

Alison Cormack asked how the board members should think about the tuition costs. Loretta Melby gave a general overview of tuition and explained the tuition for all pre-licensure programs are listed. Alison Cormack suggested the NEC make a comment about how the tuition compares to similar programs. Loretta Melby will look into this request with the NECs.

Patricia Wynne would like Enlightened Enforcement to be agendized so they can learn about the process.

Shannon Johnson said this just started and she'll do what she can.

Loretta Melby added that DCA must approve the release of information.

Alison Cormack asked if the BRN sends out a newsletter to nurses.

Loretta Melby said the BRN Report is sent out. Recruitment is done in the newsletter and in other ways for the Expert Witness Program.

Loretta Melby discussed a public member attending at their physical location showing symptoms of illness sitting next to Vicki Granowitz and Vicki Granowitz immediately using bleach wipes as soon as the member left to avoid getting sick due to her chronic illness. Loretta Melby also discussed the Intervention Evaluation Committee meetings with 44 meetings per year. She discussed the staff requirements to handle all the meetings. She discussed participation in person versus virtually.
