**Goals and Objectives  
2015-2016 Summary of Accomplishments**

**GOAL 1:**           **Keep the Board of Registered Nursing informed about pertinent legislation and regulations that may affect nursing practice, education, and nurses' roles in the delivery of health care and administrative functions of the Board.**

**OBJECTIVE: 1.1**    Analyze legislative proposals and make position recommendations to the Board at each Board meeting.

**The committee provided information and analyses of each bill followed, and made recommendations to the Board at each Board meeting.**

During the 2015-2016 Legislative Session, many bills of general interest to the Board or those having potential impact on the administration of the Board were followed. Although these bills address many subjects, each affects registered nursing in some way. The Board followed 45 bills of which 18 became law, 5 were vetoed by the Governor, and 22 either failed in committees or respective houses, or were no longer applicable to the Board.

---

**GOAL 2:**           **Monitor current legislation on behalf of the Board.**

**OBJECTIVE: 2.1**    Advocate for or against legislation as directed by the Board.

**The committee monitored legislative bills relative to the Board. Committee staff advocated for bills supported by the Board and voiced the concerns of the Board for those bills to which it expressed its opposition.**

- Committee staff continued to respond to public inquires concerning bills followed by the Board.
- Staff attended numerous legislative committee hearings concerning bills followed by the Board.

**OBJECTIVE: 2.2**    Review and suggest appropriate amendments as necessary.

**The committee staff participated in recommending and writing amendments to specific bills relative to Board action.**

- Committee staff attended legislative meetings and communicated with legislators' staff to articulate the Board's position on specific bills.

- Committee staff sent six letters to various senators and assembly members expressing the Board's position of support or opposition to their respective bills.
- The Board sent one letter to the Governor stating its position of opposition to two bills.

OBJECTIVE 2.3 Provide testimony to the Legislature, on behalf of the Board, as requested.

**Board members and BRN administrators provided testimony related to legislation as well as contacted legislators or their staff related to the concerns expressed during the Sunset Review process related to the Board initiating legislation.**

**GOAL 3: Serve as a resource to other Board Committees on legislative and regulatory matters.**

OBJECTIVE: 3.1 Assist other Board Committees in reviewing legislative regulatory proposals.

**The committee staff served as a resource to other Board Committee members and committee liaisons concerning legislative issues that impacted their respective committees.**

**GOAL 4: Enhance the Board's process to proactively identify legislation that potentially impacts nursing and the Board.**

OBJECTIVE: 4.1 Evaluate additional resources, e.g. Internet, new legislative publications, etc., as sources of pertinent legislative information.

**Staff utilized the California Legislative Information maintained by the Legislative Council on the Internet, as well as StateNet. Legislative publications from various associations, and state publications, were also used as resources for legislative activities.**

OBJECTIVE: 4.2 Maintain consistent dialogues with Department of Consumer Affairs (DCA) Legislative Unit, Legislators and their staff.

**The committee was proactive in identifying and monitoring legislation relative to the Board.**

- Committee staff communicated with DCA legislative staff to identify proposed legislation and its potential impact on the BRN.
- Committee staff met and communicated with organizations and sponsors of legislation to articulate and clarify issues relative to the BRN.
- Committee communicated with other state departments, relative to legislation impacting the BRN.

**2016 Legislative Summary**

---

---

**During the two-year 2015-2016 Legislative Session, many bills of general interest to the Board, or those having potential impact on the administration of the Board, were followed. Although these bills address a number of subjects, each affects registered nursing in some way.**

**A Legislative Summary for 2015 was presented to the Board at its February 2016 meeting, and the legislative summaries for the bills that became law appear in those materials. Unless otherwise stated, those statutes took effect January 1, 2016.**

**In 2016, the Board continued to follow the two-year bills, the bills introduced in 2016, and bills that were amended so that they now applied to the Board. There were 32 bills followed of which 10 became law, 2 were vetoed, and 20 bills failed to move out of committee or concurrence as amended.**

**For the 2015-2016 Legislative Session, the Board followed a total of 45 bills of which 18 became law, 5 were vetoed, 2 were no longer applicable to the Board, and 20 remained in committee or their respective houses.**

**The following is a brief description of those bills that became law in 2016. Please refer to the bills themselves for more details because this summary reflects only the portions that pertain to nursing or the Board. Unless otherwise stated, the statutes of 2016 became effective January 1, 2017.**

**AB 1386 (Low)  
Chapter 374, Statutes of 2016  
Emergency medical care: epinephrine auto-injectors**

This bill permits a health care provider to issue a prescription for, and a pharmacy to dispense, an epinephrine auto-injector to an authorized entity, which is defined as any entity or organization that employs at least one person who has completed an approved training course on the emergency use of epinephrine auto-injectors.

**AB 1748 (Mayes)  
Chapter 557, Statutes of 2016  
Pupils: pupil health: opioid antagonist**

The bill authorizes school nurses or, if the school does not have a school nurse, a person who has received training regarding naloxone hydrochloride or another opioid antagonist to immediately administer naloxone hydrochloride or another opioid antagonist under certain circumstances. The bill provides that volunteers may administer naloxone hydrochloride or another opioid antagonist only by nasal spray or by auto-injector, as specified. This bill authorizes a pharmacy to furnish naloxone hydrochloride or another opioid antagonist to a school district, county office of education, or charter school if certain conditions are met.

---

**AB 2105 (Rodriguez)**  
**Chapter 410, Statutes of 2016**  
**Workforce development: allied health professions**

This bill requires the Department of Consumer Affairs to engage in a stakeholder process to update policies and remove barriers to facilitate the development of “earn and learn” training programs in the allied health professions. The bill requires that the statutory barriers identified through this process to be provided to the relevant legislative policy committee by January 1, 2020.

---

**AB 2744 (Gordon)**  
**Chapter 360, Statutes of 2016**  
**Healing arts: referrals**

This bill clarifies that the payment or receipt of consideration for advertising where a healing arts licensee offers or sells services through a third-party online advertiser shall not constitute a referral of patients when the third-party advertiser does not recommend, endorse, or otherwise select a licensee. This bill provides that the purchaser of services is entitled to a full refund in the event that the licensee determines that the service is not appropriate for the purchaser or if the purchaser declines the service for any reason and requests a refund.

---

**AB 2859 (Low)**  
**Chapter 473, Statutes of 2016**  
**Professions and vocations: retired category: licenses**

This bill authorizes any of the boards, bureaus, commissions, or programs within the Department of Consumer Affairs to establish, by regulation and with some limitations, a system for a retired category of licensure for persons not actively engaged in the practice of their profession or vocations.

---

**SB 482 (Lara)**  
**Chapter 708, Statutes of 2016**  
**Controlled substances: CURES database**

This bill requires a health care provider authorized to prescribe, order, administer, or furnish a controlled substance to consult the Controlled Substances Utilization Review and Evaluation System (CURES) prior to prescribing a Schedule II, III, or IV drug to a patient for the first time and at least once every four months thereafter if the substance remains part of the treatment of the patient. The bill provides exemptions for health care practitioners from the duty to consult the CURES database in certain circumstances. The bill clarifies that regulatory boards under the Department of Consumer Affairs that oversee practitioners who do not prescribe, order, administer, furnish, or dispense controlled substances shall not have access to CURES. The bill provides that health care providers may share CURES data with the patient.

**SB 1039 (Hill)**  
**Chapter 799, Statutes of 2016**

## **Professions and Vocations**

Related to the Nursing Practice Act:

This bill requires that the content of a continuing education course be based on generally accepted scientific principles. The bill also requires the board to audit continuing education providers, at least once every 5 years, to ensure adherence to regulatory requirements, and to withhold or rescind approval from any provider that is in violation of regulatory requirements.

The bill raises specified fees, and would provide for additional fees, to be paid by licensees and applicants for licensure or for approval, continuing approval, or substantive change to an approval of a nursing program.

Related to telephone medical advice:

This bill eliminates the Telephone Medical Advice Services Bureau. The bill instead makes the respective healing arts licensing boards responsible for enforcing the provisions related to telephone medical advice services and any other laws and regulations affecting California licensed health care professionals providing telephone medical advice services.

---

### **SB 1076 (Hernandez) Chapter 723, Statutes of 2016 General acute care hospitals: observation units**

This bill establishes new requirements for observation services provided by acute care hospitals including that observation services provided in an outpatient observation unit comply with the same nurse-to-patient ratios as emergency services. This bill requires patients receive written notice when they are receiving observation services while housed in an inpatient unit of the hospital.

---

### **SB 1139 (Lara) Chapter 786, Statutes of 2016 Health professionals: medical school programs: healing arts residency training programs: undocumented immigrants: nonimmigrant aliens: scholarships, loans, and loan repayments**

This bill prohibits specified grant, loan repayment and loan forgiveness, and scholarship programs administered the Office of Statewide Health Planning and Development from denying an application based on an applicant's citizenship or immigration status.

---

### **SB 1348 (Cannella) Chapter 174, Statutes of 2016 Licensure applications: military experience**

This bill requires each board with a governing law authorizing veterans to apply military experience and training towards licensure requirements to post information on the board's Internet Web site about the ability of veteran applicants to apply their military experience and training towards licensure requirements.
