This action without regulatory effect by the Board of Registered Nursing amends section 1417 of title 16 of the California Code of Regulations. Specifically, this action repeals the "Biennial Public Health Nurse Renewal Fee" in that section in response to Assembly Bill 2471 (Stats. 2024, c. 717) and Senate Bill 1526 (Stats. 2024, c. 497), which amended Business and Professions Code section 2816 by deleting provisions relating to renewal of a public health nurse certificate and adding a provision that states that a public health nurse certificate is not subject to renewal.

OAL approves this change without regulatory effect as meeting the requirements of California Code of Regulations, title 1, section 100.
